Title: Times New Roman, 14 point, bold, 1.15 line spacing, Title case, Scientific names should follow scientific notation)

Author Names (Times New Roman, 12 point, bold)

- All author names to appear below the article title and their order should not be changed.
- Maintain the author names in Sentence case (first letters of first, middle and last name to be capitalised, Initials also in capitals)
- Superscript author names with numbers for affiliations and all affiliations to be present below the author names in the order of the superscript numbers (affiliations need not be numbered if all authors are of same affiliation).
- For 2 authors, separate the names with 'and'.
- Superscript asterisk (\*) against Corresponding or Principal author name and their email id should be given below the affiliation.

KEY WORDS: Keywords should appear below abstract. Keywords are separated by comma and written in lower case except proper nouns. Avoid placing full stop (.) at the end of keywords. It should be formatted in Times New Roman, 11 point font with 1.15 line spacing. The section heading 'KEY WORDS' should be written in Times New Roman, 12 point bold font The heading need not be numbered

BODY OF THE MANUSCRIPT: The body of the paper should contain numbered sections as follow. The main section heading should be in Times New Roman, bold, 12 point font and uppercase The section subheadings should be Times New Roman, bold, 11 point font.

The text of the main body should be formatted in Times New Roman, 11 point font with 1.15 line spacing

NB: The results and discussion may be under separate headings also. The conclusion may be clubbed with discussion under a single heading

Acknowledgements: The acknowledgement section should not be numbered. Acknowledge those persons who helped you in the present study by providing facilities, personal assistance and funding if any.

Conflicts of interests: The authors may declare any conflicts of interests that may have influenced the outcome of the research here

*References: Should be listed in alphabetic order*. **IJCAB** follows the referencing style described below

### a. In-text citations

- Reference shall be cited with author names and year in the text of article. It should be formatted in Times New Roman, 11 point font, Italics and be inside parenthesis. The last name of the author should be given followed by the first and middle names as the initials
- The author name and the year should be separated by a comma ",". In case of articles with more than two authors, only the first author should be cited followed by "et al." If two authors are cited the author names should be separated by an 'and'

Example:

Single author-(Gilbert DA, 2018)

Two authors: (Gilbert DA & Maxim C, 2018)

More than two authors: (Gilbert DA et al., 2018)

If more than one paper is cited, they should be separated with semicolons and arranged in forward chronological order

#### Example

(Gilbert DA, 2018; Bruce G and Garry C, 2019; Wilson VG et al., 2020)

#### b. Reference List

- References which are cited in the text should be mentioned here.
- It should appear at the end of your text.

#### c. Referencing journal articles

- Elements of the Citation: Author(s) Last name and initials (Publication year). *Title of article*.
   Title of journal abbreviated. Volume (issue): pages
- Multiple author names should be separated with commas. If the paper has more than ten authors
  list only the first ten followed by et al.

**Example:** Gilbert DA, Barry GA, Kumar A (2005). *Treatment of human brucellosis: systematic review and meta-analysis of randomised controlled trials*. Sci. Rep. 336 (7646): 701-4.

### d. Referencing Books

Elements of the Citation: Author(s) – Last name and initials (Year of Publication). Title of the book, Publisher Name, Place of Publication.
 Example: McKenna DJ, Jones K, Hughes K (2000). Social care practice in rural communities. Oxford University Press, New York

#### e. Referencing edited books

Elements of the Citation: Author(s) – Last name and initials (Year of Publication). *Title of the chapter*, In: Name of the editors., Title of the book. Edition of book if later than 1st ed. Publisher Name, Place of Publication

Example: Rowlands TE, Haine LS (2009). *Acute limb ischaemia*. In: Donnelly R, London NJM eds., ABC of arterial and venous disease. 2nd ed. Blackwell Publishing, West Sussex

## Tables & Figures

- In text, tables & Figures are represented in running form or in parenthesis. Table 1 or (Table 1)
- Number the tables and figures consecutively using Arabic numerals.
- Place the tables and figures in the manuscript at positions where it has to feature in the published article
- Table caption to be placed above the table. Avoid full stop after the table caption.
- Maintain the uniformity in the digits given in table. Values should not be affected while editing the digits

- Please number the pages of the manuscript
- Italicize the species name in required places
